Course theme selected by instructor: Students learn to assess the conventions of popular 19th-century public media genres and evaluate the rhetorical strategies authors used to influence their audiences, drawing parallels to our own media landscapes.

"19th Century English Literature: 'Social Issues in Victorian Literature,'" English 4250/7250, Summer 2025. Online Instruction. Instructor of record.

A cross-listed graduate and undergraduate course that considers how diverse social issues like slavery, poverty, imperial expansion, and gender roles were taken up by both public-facing media (newspapers, periodicals) and literary genres (novels, short stories, stage plays) throughout the Victorian period.

"Survey of British Literature, Romanticism to the Present: 'Issues of Canonicity,'" English 3210 (2 sections), 2021-2025. Online instruction (8wk & 16wk). Instructor of record.

A survey of Romantic, Victorian, Modernist, and Contemporary works from the British Isles and empire, this course helps students consider characteristics of "canonical" literature within the context of broader historical and cultural developments that influenced the literature of these periods.

"Writing and Rhetoric," English 1000 (17 sections), 2019-2025. In-person and online modalities. Instructor of record.

University-required writing instruction that helps students develop awareness of various rhetorical situations and how to analyze them, and offers practice in gathering and evaluating sources, taking notes and finding patterns, and producing texts that meet the rhetorical goals of different genres.

 A multi-genre course surveying Victorian literary and medical texts alongside feminist, queer, and gender studies scholarship to examine how gendered relations of power can become deeply entangled with medical assumptions, experiences, diagnoses, and treatments—during this period and beyond.

 An introduction to affect theory, this course helps students develop skills in analyzing and interpreting criticism and applying critical concepts to different genres of literature and film, from cross-dressing on the Shakespearean stage to "meet cutes" in contemporary romantic comedies.

 An introduction to Writing Studies, this course helps students develop reading, writing, and analysis skills, prompting them to think critically about how writing and rhetoric both shape and are shaped by the cultural, political, and communal landscapes in which we find them.

 A lecture with smaller TA-led sessions, this course discussed the invention and progression of different subgenres of mystery fiction, helping students develop a robust literary vocabulary, teaching them close-reading skills, and attending to cultural and literary contexts in which specific texts were produced.
